Minimum 10 research papers excluding review articles in the relevant area as advertised, as first author/corresponding author in reputed journals having impact factor 3.0 and above.

**Or**

If the candidate has industry experience more than or equal to the minimum requirement of experience as per the NIPER statues, then the publication criteria shall be 5.

**Weightage:**

- i. One Patent is considered to be equivalent to one research paper as first author/corresponding author with impact factor 3.0 and above.
- ii. One research paper as first author/corresponding author in relevant research area in a Journal of high impact factor of 10 and above is given double weightage i.e. considered equal to two research papers.
